SITUATION

After a merger and acquisition, a large life sciences company needed to drastically cut cost and transform their business to recognize promised operational and cost synergies in the new company. Complicating this were several redundant PeopleSoft systems with these specific issues:

COMPLIANCE

- Data was being kept longer than required retention periods, leaving the door open for legal judgments on data that should have been disposed of.
- Stable and consistent formats were necessary for W2 and Pay Slips; the legacy systems could not maintain that standard.

GOVERNANCE

• Data was duplicated in multiple systems, creating gaps and misalignment in the data. Archiving the data allowed for clean streamlined data storage in ONE system.

COSTS

- License fees maintaining multiple instances of PeopleSoft, simply to look up old information, were astronomically expensive.
 - Hardware Assets services of multiple data centers hosting multiple servers were no longer needed once the information was archived into a central repository.
 - **Knowledge costs** using PeopleSoft takes a great deal of training and understanding to retrieve simple datasets. Specialized SQL knowledge precluded the average user from being fully self-service, and is instead reliant on PeopleSoft experts.

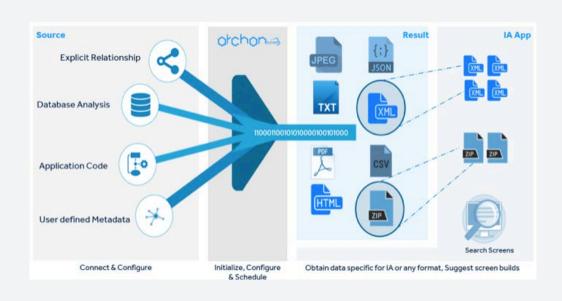

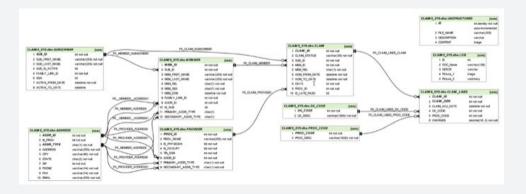
